ii) The Management has purchased 8.6 acre land in the name of the college at Vaniyambadi, Vellore District in DOC No. 2830, 2927, 57, 214, 242, 983 to 293 and 2823.

iii) Agreement in stamp paper to abide by all conditions prescribed by the Government.

2) The Government have examined the proposal carefully and they permit Vaniyambadi Muslim Educational Society to open a women's College in the name and style of Islamiah Women's Arts and Science College with the following courses from the academic year 1997-98.

1. B.Sc. Home Science
2. B.Sc. Biochemistry
3. B.A. Corporate Secretaryship.

3) The management is permitted to start the college during 1997-98 temporarily at Islamiah Girls Higher Secondary School, Vaniyambadi and it should be shifted to the permanent building during 1998-99 to the constructed in the land mentioned in para 1(ii) above
